

## I Heart the Parks Sweepstakes Grand Prize Official Rules

Terms, Conditions and Rules (the "Rules") for Online Sweepstakes (the "Promotion")

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCE OF WINNING.

This Promotion is governed by the laws of the Arizona, and all claims must be resolved in the federal or state courts located in Arizona. You are not authorized to participate in the Promotion if you are not located within the United States.

1. Eligibility. Entrant must be a legal resident of the United States who are at least 18 years of age or have reached the age of majority (as defined by the law of the state in which entrant resides) as of **May 22, 2017**. 4. How to Win: Odds of Winning.
